6) Quote to Fix Fire Station Roof The fire department has been having issues with the roof leaking. The station was built in 2001. After finding out what was causing the problem, they received a quote from Cresco Building Service for \$1,755.00 for the supplies needed for the roof ridge. It was moved by Wright, seconded by Schlein, to approve the amount of \$1,755.00. Carried Unanimously.

7) Installing New Monona Billboard Public Works Director, Adam Jones, was looking for approval to obtain a telehandler or two bucket trucks to hang the billboards and to add grommets to the vinyl signs to help with securing the sign to the billboard.
